Rare May Nor'easter

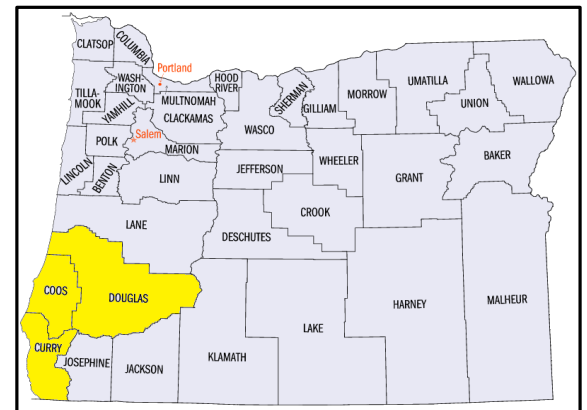
- As if the Northeast hasn't received enough rain lately, a rainstorm will drench the region into Friday and will evolve into a May nor'easter for New England.
- Through Thursday night, a general 1-2 inches of rain is forecast with higher amounts in parts of western Pennsylvania, western Maryland and northeastern West Virginia, as well as in southeastern New England.
- The combination of the rain, wind and cool air from the ocean will create the raw conditions in the Northeast.
- Winds from the east and northeast will average 30-40 mph along the coast with locally higher gusts. In a true nor'easter fashion, gusts from Cape Cod, Massachusetts, northward to Maine, can reach as high as 60 mph.
- The same winds off the ocean will also push tide levels up to the point where minor flooding can occur during times of high tide, along with minor beach erosion.



Disaster Declaration Requests

Oregon

- On May 19, Governor Tina Kotek requested a Major Declaration for severe storms, flooding, landslides and mudslides that occurred March 13th-20th.
- The Governor is requesting individual assistance for the following counties: Coos, Curry and Douglas.
- Beginning on February 24, 2025, ongoing storms have caused significant flooding and landslides throughout Oregon, resulting in one fatality, critical transportation failures and loss of power and communications capabilities.
- In Coos County, traffic officials closed multiple roads as floodwaters caused severe damage, including a sinkhole.
- In Douglas County, the emergency response included water-related rescues, home evacuations, freeing people who were trapped, and providing aid to nearby safety agencies.
- According to a press release, 32 adults, 8 children, and 15 pets were brought to safety in Douglas County alone.
- Governor Tina Kotek declared a state of emergency on March 18th.



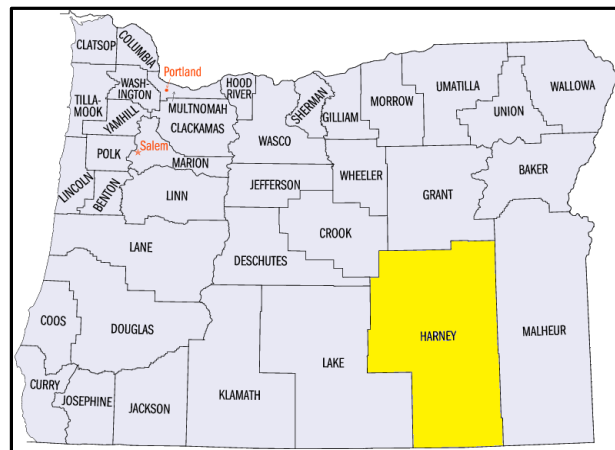

Oregon

- On May 19, Governor Tina Kotek requested a Major Declaration for severe storms and flooding that occurred March 13th – April 15th. She is requesting individual assistance for Harney County and the Burns Paiute Tribal Lands.
- Rapid snowmelt combined with continued precipitation has overwhelmed waterways and wastewater systems, causing significant flooding.
- Roads, bridges, and culverts have been inundated, disrupting emergency services, essential operations, and local commerce. Floodwater has damaged homes, businesses, agricultural lands, and livestock areas.
- The American Red Cross has reported 952 homes received “major damage” in the Burns area and on the Burns Paiute Indian Reservation.
- The Governor declared a state of emergency on March 29, 2025.
