

Eastern Pacific Tropical Activity Tropical Storm Alvin

- Tropical Storm Alvin is unraveling quickly as it churns large swells towards portions of western mainland Mexico and the Baja California Peninsula.
- The FOX Forecast Center said land impacts are expected to be minimal.
- Alvin's winds peaked at 60 mph Friday morning after forming in the Eastern Pacific south of Mexico the day prior.



 Located about 445 miles south-southeast of the southern tip of Mexico's Baja California Peninsula

Disturbance 1

- Area of low pressure could form by the middle part of next week.
- Located offshore of the coasts of Central America and southern Mexico.
- Conditions appear favorable for some development of this system.
- Currently moving westward to west-northwestward at around 10to 156 MPH.
- Formation chance through 48 hours Low (0%)
- Formation change through 7 days Low (20%)

Disaster Declaration Request Indiana

- On May 28, Indiana Governor Mike Braun requested a presidential disaster declaration through FEMA.
- The request includes the following counties: Clark, Crawford, Floyd, Harrison, Jefferson, Switzerland.
- This request covers the storms and flooding that took place from March 30 through April 9.
- On Aprill 11, Governor Braun declared a state of emergency for 18 counties in Indiana.
- A line of strong storms moved through Indiana, prompting tornado warnings throughout the states in the afternoon and evening.
- The Floyd County Emergency Services director told WDRB that Green Valley Road in New Albany was likely one of the worst hit areas.
- More than 400,000 homes and businesses lost power across Michigan, Wisconsin, Indiana, Ohio and Kentucky, according to PowerOutage.us.
